First Proposal: Disposal of Surplus

We make it our basic principle to pay dividends in a stable and steady way to shareholders who deposit their valuable capital with us while retaining the earnings that are necessary to develop future business and reinforce business structure.

Taking into account earnings, expenses, and other figures for the current fiscal year, we will pay dividends at the end of the current fiscal year as follows:

- (1) Type of dividend property Cash
- (2) Matters concerning allotment of dividend property and total dividends Dividend allocation: ¥13 per common share of the Company. Total amount of dividends: ¥611,560,521 Moreover, for the current fiscal year, annual dividends including interim dividends amount to ¥25 per common share.

 - Liability limitation agreements with external directors

The Company has entered into agreements with Mr. Katsuhisa Furuta, Mr. Ichiro Inasaki, and Mr. Kazunao Kudo to limit the liability for compensation for damage as referred to in Article 423, paragraph 1 of the Companies Act pursuant to Article 427, paragraph 1 of the Act. The limit of liability for compensation for damage under the agreement shall be the minimum limit of liability as set forth in Article 425, paragraph 1 of the Companies Act. When they are reappointed, the Company is to continue the agreements. In addition, when Mr. Kenzo Nonami is appointed, the Company is to enter into a liability limitation agreement with him on the same terms.
